
Petrol prices riding the bul

aking up, everyday morning to see the petroleum prices breach towards new highs is probably one of the scariest nightmares anyone commuting daily on a vehicle can have due to how deep a hole it can burn in their pockets. For us, it may look like the Government is struggling to control or has no control over the price spikes despite the world coming out of the pandemic. However, to understand the situation, we need to take a step back and have a deeper look into the issue.

In India, we rely heavily on imported fuel to satisfy the country's fuel hunger. This also means that India has to spend more to purchase crude oil. Looking at the currency's exchange value trend, the Indian rupee has been moving up towards nearly Rs. 75 per United States Dollar. This, in turn, makes the imported products much more expensive for Indians. Moreover, there has been a tremendous drop in the supply of coal, bringing its international demand up.

So why cannot the Government just control the prices? This used to be the case back in 2010. The Government was responsible for fixing the price of the fuel. The Government, every two weeks, revised these prices. But in 2014, the prices for petrol was deregulated. This mean the Government no longer had control over the prices like it used to. Ever since the petrol prices are being revised daily. According to Lok Sabha, Public sector oil marketing companies decide these prices by taking various factors such as exchange rate, tax structure, freight charges, and many other cost elements.

But something that gets overlooked is the fact that this is not exactly the case! The price of petrol and diesel in India is not determined by the actual costs incurred by PSU refiners such as Indian Oil, HPCL and BPCL on crude oil sourcing, refining and marketing. Rather, a formula called Trade Parity Price (TPP) is used to price it. The

formula assumes that 80 per cent of the petrol is imported into India and 20 per cent is exported. So, petrol prices in India are more determined by the prices of the same in the international market.

With Brent oil prices increasing and a sharp fall in the supply of fuel, it is obvious as to why the prices of petroleum have been increasing. Oil marketing companies like Indian Oil need not necessarily take the hit of the price increase, rather they would just pass it down to the consumer. The Central Government had also increased levies on Petrol last year due to slow economic activity during the pandemic. Central and state taxes currently account for about 53.5 per cent of the pump price of petrol and about 47.6 per cent of the pump price of diesel in Delhi. As per the Finance Ministry, the Government has no plans to bring

down the taxes to pre-covid levels. The Central Government wisely used the fiscal space generated by fuel charges to expedite capital investments and pursue a variety of socio-economic development programmes. More than 60% of fuel duties are set aside for capital expenditures. States, like the Federal Government, require financial resources to fund development projects, and fuel taxes are an essential source of revenue for them. Reduced crude oil usage is the only long-term solution. In this strategic framework, the continued campaign to promote e-vehicles, boost ethanol blending in gasoline, and promote alternative fuels like Green H2 should be seen. ■

hiba Inu, created in August 2020 by Ryoshi, is a joke coin or meme coin which was launched as a rival to Dogecoin.

Shiba Inu has been in the news for two reasons. Recently, Tesla founder Elon Musk had tweeted stating he would like to own a Shiba pup that excited the crypto market and the prices rose by 300 per cent.

The prices of Shiba Inucoins fell by around 40 per cent after the 27-yearold Russian Canadian Billionaire Vitalik Buterin donated 50 trillion Shiba Inu coins to India Covid Crypto Relief Fund, run by Indian crypto entrepreneur Sandeep Nailwal Shiba Inu coin (SHIB) is an Ethereumbased ERC-20 token that has risen in popularity this year, largely because of its dog-themed ecosystem, speculation on its price by retail investors and

The official Shib Twitter account, for example, has over 1.2 million followers - more than leading crypto companies such as Cardano, Kraken and Solana.

The digital asset was inspired by the Japanese breed of dog of the same name, which sparked a viral meme trend in 2013 and subsequently led to the creation of the infamous dogecoin cryptocurrency. Shiba inu, along with dogecoin and the hundreds of other pet-inspired digital assets, have become collectively known in the industry as "meme coins."

Ordinarily, a meme coin offers owners little to no utility compared with more established cryptocurrencies such as bitcoin and ether. In the case of Shiba Inu coin, however, there seems to be a legitimate attempt by the development team to provide more value to SHIB holders, including launching a decentralized exchange in July.

Key Features of Shiba Inu Coin

So other than being another doggy-themed cryptocurrency, what is the shib coin all about?

The first notable thing about Shiba Inu coin is its total supply. A total of 1 quadrillion SHIB tokens were minted during its official launch in 2020. A quadrillion is a number followed by 15 zeros. Some 50% of the supply of Shiba Inu was locked in Uniswap SHIB/ETH liquidity pool -a decentralized exchange where users deposit pairs of assets into

liquidity pools that other investors can trade against. That is known as an automated market maker system.

The other 50% of shib token's supply was donated to Ethereum's founder, Vitalik Buterin, who burned a vast majority of them by sending the tokens to a dead crypto wallet address. The remaining tokens (worth \$1.2) billion at the time) were donated to an Indian COVID-19 relief cause and other charities. The Shiba Inu coin universe also consists of a decentralized exchange, called Shibaswap, and two other tokens, "LEASH" and "BONE,". Finally, the community is also championing a rescue campaign for Shiba Inudogs. All you need to do is make purchases on Amazon through smile.amazon.com and select Shiba Inu Rescue Association (as your preferred nongovernmental organization). This will allow a percentage of your purchase to be donated to a cause focusing on helping Shiba Inu dogs in need.



What is Shibaswap?

Shibaswap is a decentralized exchange – a type of peer-to-peer trading platform similar to Uniswap that allows users to trade SHIB and other cryptocurrencies without an intermediary company. It also allows users to provide liquidity (deposit funds into pools that other traders can use to trade against) and stake tokens (deposit them into a smart contract) to earn interest using shib token and two additional ERC-20 tokens that exist in the Shiba ecosystem: Bone ShibaSwap (ticker: BONE):

Bone is designed to function as the platform's governance token, with a total supply of 250 million coins. That means holders of bone tokens are able to propose and vote on changes to the Shiba protocol via its "Doggy DAO." It's also minted and rewarded to users who provide liquidity on the platform.

Doge Killer (ticker: LEASH): This

was originally launched as a rebase token (also known as an elastic token), a type of token similar to an algorithmic stablecoin where the supply automatically increases and decreases via a computer algorithm to keep its price pegged to another asset. In this case, the leash's supply is adjusted to track the price of doge at a rate of 1/1,000. For example, if the price of dogecoin was \$0.05, the supply of leash would change (mint new tokens or destroy coins in circulation) to adjust the price of the leash to \$50. Leash tokens have since been "unleashed," and now no longer track the price of doge. With a scarce supply of just 107,647 tokens, the leash has become the main store of value coins for many Shiba Inu owners.

SHIBASWAP **FUNCTIONS**

On the ShibaSwap homepage, there are six functions available that incorporate the ecosystem's three native coins, shib, leash and bone:

How different is Shiba Inu?

The launch of Shiba Inu failed to gain traction at the beginning, but it began to make a splash around the same time Tesla CEO Elon Musk and other prominent individuals started to take interest in Dogecoin. Tech billionaire Musk in particular has been one of the most vocal supporters of Dogecoin. Dubbed the "Dogefather," Musk was even voted as the project's new unofficial CEO. In the run-up to his appearance on "Saturday Night Live" in May, Musk hinted that he would mention Dogecoin during the show. That

fuelled an unprecedented dogecoin price rally, which boosted the value of shib. In five days, the price of shib increased by over 2,000%. The coin subsequently experienced a price slump along with the market-wide crash sparked by Musk's an<mark>nouncement</mark> that Tesla would no longer accept bitcoin as a form of payment. It would later recover some of the lost value in the first week of October when Musk shared the picture and name of his new Shiba Inu puppy. All in all, SHIB's price gained over 27,000,000% from January to October.

Dig

Digging is the liquidity pool function on the ShibaSwap platform. Here, users can deposit crypto assets in pairs to existing liquidity pools on the platform, or create their own. As a reward, liquidity providers receive ShibaSwap liquidity pool tokens SSLP). Those tokens represent their share of liquidity in the pool and entitle holders to receive free bone tokens upon redemption.

Bury

This refers to where users can stake their shib, leash and bone in order to generate high-interest yields paid in bone tokens. At press time, the rates were 171%, 266% and 814%, respectively. Once staked, users receive a token that represents their staked amount in xSHIB, xLEASH or xBONE.

33% of bone rewards from staking are available immediately, while the remaining 66% are locked up for six months.

NFTs

Here, users can trade 10,000 unique nonfungible tokens called "Shiboshis" - pixelated Shiba Inu dog cartoons similar to CryptoPunks with different traits, some rarer than others.

Bonefolio

This is an analytics dashboard where users can explore current interest rates and track their vield returns.

Woof

"Woofing" is the function for redeeming bone rewards by cashing out SSLP tokens.

Swap

This is the exchange feature of the ShibaSwap platform where users can swap between multiple assets.

The Elon Musk Effect



Dogecoin has been developed using the same technology as Bitcoin. Shiba Inu tokens are powered by Ethereum. Fungible tokens like Shiba Inu are ERC-20 tokens and nonfungible tokens (NFTs) use the ERC-721 token standard of the Ethereum platform. SHIB token is our first token and allows users to hold Billions or even Trillions of them, the official website mentions. More additions are coming up as per the Shiba Inu's website. The creators plan to launch Bone Dogecoin Killer, the next coin in future.


Expert Opinions about Shiba Inu Coin

Investorplace.com had recently conducted detailed research on the Shiba Inu coin which conveyed that the predictions of the price of currency have been heating up due to the enormous gains of the cryptocurrency.

However, it is seen that the investors are not yet rushing to invest their money into the new cryptocurrency. Investorplace.

com had done a dive into the number of predictions about the new coin where they found out WalletInvestor has suggested that Shiba Inu coin is not a good investment for the long term. They also have an estimated prediction that the value of this cryptocurrency would see a downfall by the end of 2022 to somewhere in between USD

0.000029 to USD 0.000016. But DigitalCoinPrice has predicted that there would be an increase in the price of the cryptocurrency and would see a jump by the end of 2021 to USD 0.000044. Gov Capital has predicted that Shiba Inu Coin would see a huge drop falling to USD 0.000006. ■

ver imagined being in possession of such a power that could send you back in time after a disaster or a life-threatening incident takes place around you and takes you back just in the right time where you are able to prevent the calamity that is about to come by using your hindsight. Well, this cannot be possible for any normal human being out there but for the protagonist of this anime it's a different story.

Boku Dake ga Inai Machi, also known as Erased is a short 12 episodes anime released in the summer of 2017. It's an adaptation of a manga written by Kei Sanbe. This is going to be a spoilerfree review of this anime with only the basic premise so that you can get a headstart to what you are actually getting yourself into. The genre of this show is mystery and supernatural.

The anime starts with a 29-year-old man Satoru Fujinuma, he is a struggling manga artist and isn't really able to come up with any great or appealing ideas for his manga and also works as a deliveryman at a pizza shop to make both ends meet. He seems like any other normal person but that's not quite the case, as he is in possession of a power called "Revival" that sends him back in time (without his consent) in order to prevent any life-threatening incident from happening as I have already explained in the first paragraph.

He is an introvert and a shy person who always had a hard time understanding other people's emotions but now tries to make efforts in getting along with other people or at least pretending to because of an incident

that happened in his childhood for which he finds himself partly responsible for not being able to save his friends due to his lack of communication skills or for not giving them enough attention.

Satoru's ability to travel back in time is definitely a very rare gift and anyone would think that he is lucky to have such a superpower, but being the one to have this unusual ability also means that now he has the responsibility of preventing the incident before it occurs cause he is the only one who is aware of what is going to happen and tries his best in order to save other people's lives by putting his own on-line. In the first episode, we see him preventing a truck from hitting a child using his powers, but even after saving the child, he himself gets injured in the process.

Usually, his power sends him 10 or 15 minutes back in time only to so much where he is just able to prevent the accident, but one day he gets accused of a murder which he did not commit and then in order to prevent it from happening the revival takes him 18 years back in time, when he was a mere 11-year-old child but now with a brain of 29-year-old. Now he must figure out what needs to be done at this time in order to prevent the murder from happening 18 years later. Now, this is what the forte of this anime is that how in a body of an 11-year-old he solves the mystery and stop the killer, and since he is in the time when his friends were still alive he has got one more chance to save them as well.

To be honest, there are many animes out there who have a similar type of story, however, there is uniqueness in its plot and the way it's narrated. Comparing it with the other anime wouldn't be fair cause it has handled the story with perfection. 
