WOMEN EMPOWERMENT SCHEMES

....BY OUR PM SHRI NARENDRA MODI

As the Modi's Government completes two years in office one of the highlights could be its focus on the country's women. If all goes as per the plan, India could soon have 1.25 crore women entrepreneurs.

The Stand Up India Scheme- the Government's Flagship Programme mandates each Government Bank Branch to give one loan to a woman entrepreneur besides one to a borrower categorised as an SC or ST or even a Dalit.

Other Schemes of Government include Beti Bachao, Beti Padhao Yojana, that was initiated in 2015 to improve the child sex ratio in several remote corners in the country, by ensuring that girl children are born and can go to school.

The Sukanya Samriddhi Yojana was also launched wherein parents/guardians could make investments in the names of two-three daughter wards to fund either their education or marriages after they turn eighteen.

In 2015. Ms Arundati Bhattacharya, Chairperson of the State run SBI said that as much as 49% of the accounts opened under the Pradhan Mantri Jan Dhan Yojana were held by women.

In 2015, when Ms Maneka Gandhi, Minister for Women and Child Development suggested that it should become mandatory for companies to reveal in their annual reports if they have constituted Internal Complaints Committees to look into instances of sexual harassment.

Pradhan Mantri Mudra Yojna, a Scheme to provide loans to the unfunded successfully disbursed loans worth Rs 1.8 crore in 2016-2017 a tweet from the officials of BJP, 70% of the beneficiaries are women.

All in all, it's just two years so as we begin the journey in the third one, it remains to be seen his government puts a holistic idea of women's empowerment into action.

H-1B VISA

The H-1B Visa is a non-immigrant Visa which allows the employers to temporarily employ the foreign workers for speciality occupations in the United States. The speciality occupation is defined by regulations as requiring theoretical and practical application of a highly specialised knowledge in various fields with a minimum bachelor's degree or its equivalent.

If, in case the foreign workers under H-1B Visa quits the employment or is dismissed from the employer, then the worker must apply and be granted to another non-immigrant visa or change the employer or leave the United States. In the Fiscal Year 2017-18, the United States citizenship and immigration services received 1,99,000 petitions in between April 3, 2017 and April 7, 2017 the United States Citizenship and Immigration Services granted 20,000 master degree petitions and 65,000 bachelor's degree petitions through the lottery system on April 11, 2017 and was announced on April 17, 2017.

This scenario changed where more Indians living in US wants job back home after Donald Trump became the President of U.S.A, the world's largest economy.

The number of Indians who wants to come back to India after this, is increased by ten times almost. There were approximately 600 US based Indians seeking jobs in home country in December 2016, but this raised to 7,000 in March 2017. This data is the result of crackdown by Trump administration on the Job Visas for the skilled workers, including software engineers from India. USCIS says, the foreign employees for H-1B Visa for 2018 is declined for the first time in five years. The impact would be felt in US too, who were benefitted from skilled IT workers (available at much lower cost compared to American workers).

Trump has recently signed an order, to make reforms in issue of visas only to high skilled (not on lottery system) and replace as much as possible with the US workers. Now, it's only a wait and watch game to assess the actual impact of this visa issue on the IT industry. Most of them have felt this already and are altering their future business strategies.

EDUCATION SYSTEM IN CHINA

Since the end of the Cultural Revolution (1966-76), the education system is China has been geared towards economic modernisation. In 1985, the national government ceded responsibility for basic education to local government through the Central Committee of the Chinese Communist Party's decision on the reform of the educational structure.

In unveiling the education reform plan in May 1985, the authorities called for nine years of compulsory education and the establishment of the State Education Commission. In 1986 16.8 percent of the State Budget was earmarked for education, compared with 10.4 percent in 1984. Since 1949, education has been a main focus and a controversial subject in China.

As per 2015, the Government operated primary and lower secondary school in China having 28.8 million students. The Chinese Education System is divided into three years of Kindergarten, six years of Primary School and three to six years of Secondary Education, often followed by several years of higher education. Kindergarten and Primary Schools are usually run by local authorities or even private enterprises. But whether you decide to send your child to a state school or an international school, you should get ready for a very competitive admission process and exorbitant tuition fees.

There are problems in the educational system, such as unequal opportunity, expensive tuition and difficult standards for admission. There are also issues with the course content and teaching methods.

Prof. Sur Guangwen expressed that one of the existing problems in the system is the high tuition fee. For example, an undergraduate student has to pay \$800 every year and it also drastically varies among different sectors. LIN MU states that the education fund from the Chinese regime's budget only accounts for fifty three percent of the total education expenses.

Pre-Primary and Primary Education in China

In China, children begin school at the age of seven (or six if they live in Beijing, Shanghai or other major cities) and attend classes on five days a week. Before that, children often attend pre-school or kindergarten for about one to three years. The type of education children receive there range from nursery classes and seasonal kindergarten in poorer areas of the country to top-notch pre-primary education. At the age of seven children began primary education in major urban areas, such as Shanghai and Beijing. All in all 60% of the allocated time of instruction is dedicated to Chinese and Maths, also called "The Big Two". Additionally, children are instructed in music, art, morals, society and nature and also take practical work classes. Some schools also start to teach foreign languages towards the end of primary school and add extra-curricular activities.

Secondary Education in China

Between the ages of twelve and seventeen, children attend secondary school in China. Public secondary school are often divided into junior middle schools and senior middle schools, each of them three years long. The main goal of most secondary schools is to prepare these students to higher education. In fact, the quality of a secondary school is often measured by the number of students they send to college. Apart from their regular workload they also have to prepare for the GAOKAO, the National Higher Education Entrance Examination which is the basis for recruiting students for institutions of higher education.

This nine hour exam is very difficult and only 40% of students pass it in the first place. The exam tests the students skills and knowledge in Chinese, Mathematics, Foreign Language and a few other optional subjects. According to their results, they will then be admitted to top universities, regular universities or institutions which operate on a provisional level. The higher the number of students who go on to attend top universities, the higher the popularity of the secondary school and the students who graduate from a Chinese University will later find a job and have a thrilling career.

LONDON EDUCATION SYSTEM

London has the largest student population of any British City, although not the highest per capita. Universities in London may be divided into two groups. First, the Federal University of London, which, with over 1,20,000 students, is the largest contact teaching university in the United Kingdom (smaller only than the distance-education Open University). It comprises 19 colleges and 12 institutes, as well as a distance learning External System Constituent Colleges have a high degree of autonomy, controlling their own admission and degree programmes, and are effectively universities in their own right. The largest and most well-known University of London Colleges include (in order of student population size) King's College London, University College London Birkbeck, Queen Mary, The London School of Economics and Political Science, Royal Holloway, Goldsmiths and the Institute of Education. Smaller schools and institutes (with fewer than 5,000 students) include the School of Oriental and African Studies (SOAS), the London Business School, the School of Pharmacy, the London School of Hygiene and Tropical Medicine, St George's Hospital Medical School and Central School of Speech and Drama. Traditionally all of the University of London institutions awarded degrees from the University of London itself, and not from the individual college or institution, but this changed in 2007 & 2008

when King's College London, the London School of Economics, University College London and the Institute of Education remained within the University of London System, but began awarding their own degrees. Imperial College London was a part of the University of London until 2007, but is now a separate institution.

Secondly, there are other universities not part of the University of London, most of which were polytechnics until UK polytechnics were granted university status by a 1992 Act of Parliament. Among these are the University of Westminster, London South Bank University, University of Greenwich, City University London, Middlesex University, London Metropolitan University, Brunel University, University of West London, the University of East London and various other higher education institutions.

Some of the Universities for research are Imperial College London, King's College London, LSE and UCL are leading centres of research and stand alongside MIT, Berkeley, Princeton, Yale and other US Universities in terms of international reputation. Most of the leading British learned societies are based in London. The Royal Institution is a historic and important repository and proponent of the acquisition of scientific knowledge through research and study.

London also has many further education colleges funded by the Learning and Skills Council. Traditionally these were clearly separated from the higher education system, and offered vocational education below university level, but this distinction is breaking down and many further education colleges now offer university level courses validated by a local university and prepare students for university entrance as well as providing vocational courses.

London is also known as a city that is mainly populated by cultures from other parts of the globe and many schools now in London have to even teach foreign languages to children which is embedded in the curriculum.


